K.E.I. inserts a Return Authorization (RA) form with a UPS Call Tag attached in each part shipped for warranty consideration. Defective or malfunctioning products must be returned to K.E.I. 2350 W. Commerce, Dallas, TX 75212 for Warranty consideration. If a K.E.I. part is not returned within 10 working days, K.E.I. will issue an Invoice to owner of the K.E.I. product, which will include the freight charge to ship the replacement part as well as the cost of the UPS Call Tag. **K.E.I.** reserves the right for special consideration. **K.E.I.** will pay regular ground freight charges for warranties covered and returned to customer. **K.E.I.**, under certain conditions, will pay for ND-Air Freight on OEM Installed Warranty shipments. All After-Market installs are responsible for added cost of airfreight charges or any nonstandard shipping method.

Warranty of **K.E.I.** products commences upon delivery of product to the customer. Delivery date and proof of purchase will be required. Warranty is limited to original owner of product.
